(U//FOUO) Situational Awareness: RIVERA



(U//FOUO) [REDACTED], **Robert [REDACTED]** was encountered on the DPS-HQ campus on 06/03/2016 at 10:05 AM between Building E and Building C.

(U//FOUO) [REDACTED] approached a DPS-ICT employee and asked for assistance with calling off the “nonstop government monitoring” he believes is surveilling him. [REDACTED] also attempted to follow a female DPS employee into Building A by “piggybacking” through a secure door. DPS Troopers detained [REDACTED] on 06/03/2016 and issued him a **Criminal Trespass Warning**.

(U//FOUO) **Be advised that [REDACTED] has expressed intent to return to the DPS-HQ campus.** He is known to wear a small video camera (such as a lapel camera) and he has posted footage of the Fleet Operations area to social media. [REDACTED] appears to target females wearing earbuds or headphones.



As you can see above in the pic mostly men are becoming a prime target at for targeting. Since African American men are denied housing housing rights if they become a felon especially they are forced to live in half way houses . This program is based on micro managing people . DHS and its fusion centers have been noted to also support Citizens Corps which is under FEMA and DHS and should be labeled as an extreme terrorism threat ! Some of it stakeholders are linked to racist groups.

Why our military is a stakeholder to DHS and Fusion Centers poses not only a threat to our national security but our communities . These programs are based off for profit schemes human trafficking people like cattle so ngos and other non profits and corporations can make millions under the false guise of community policing and national security. This gang stalking program has made its way into the corporate sector.

My story on what happened during my visit to the fusion center and I am willing to take a polygraph test against any person which is making false statements against me and I am currently looking for a polygrapher to prove my honesty.

(1.) I went to the Fusion Center since local police advised me at a Coffee with a cop meeting to speak to the Fusion Center staff about my harassment and to file a complaint on Citizens Corps which I later discovered was a stakeholder to Dept. of Public Safety which was infact the Fusion Center.

(2.) I went to the office as directed by police to later notice that I was required to have a security badge to enter. I was unaware of this since a man actually opened the door for me to enter not a women as the report stated so I assumed local police next door had contacted the facility and told them that a guest was coming and I had also went to the police station located in the back of the facility to ask for info where I was supposed to go

to. I was directed to park in the back of the off the facility and to head to the back door which I did. Once inside I explained why I was there and an older man behind at the front desk said I needed to go to another building which was the state governors Emergency Management office . I was tired from homework so I figured Id go another day. I was never issued a no trespassing citation warning that day and it was the only time I every entered inside a DPS office.

(3) I go back to the Fusion Center aka DPS on Lamar Blvd In Austin , Texas with load of files on 6/03/16 with some photos and videos showing a group called Citizens Corps along with an array of public and private stakeholders performing what appears to be highly illegal intrusive community policing to the point where neighbors to this day admit in Texas that it was tied to policing groups like Citizens Corps. My encounters where with freemasons, eastern star, Rotary Club, Lions Club, American Legion and other stakeholders which I believe can be linked to Infragard which law enforcement had confronted in another state for harassment towards me.

(4) While at the Fusion Center on 6/03/16 I spoke with a Joint Counter Terrorism Agent from the FBI. I had explained to him that I had been harassed by Citizens Corps and that police report was filed but that the police said the case was a civil suit so they where allowed to harass me unless I sued. While I was there I noticed what appeared to be around 25 -30 women exit a building it was the state governors emergency management office and a few women pointed at me. I could hear a women say don't do it . A women emerges from the group and as she was up to me she put on some white earphones and another man came over with here to give me a hard time. I do not target women due to wearing earplugs this statement from the fusion center is false. Whats odd is that multiple police told me that was trespassing when I was told prior by police it was okay to go there so I planned on knocking on the door . The FBI Joint Counter terrorism agent detained the women for trespassing, but she exited a fusion center office with literally the entire staff to point at me and she confront me while seeking help from the FBI staff. Odd the report is missing these facts. Note that I never made it to there office I spoke with a FBI Joint Counter Terrorism agent in the parking lot area about which office I needed to go to and never made it to an office .

(5) I ended up getting harassed there as I was in the community so I said I would be back to issue your Fusion Center with court paper work to summon them to court .

(6) I spoke with multiple attorneys concerning the incident. I was advised to try to get footage from cars in a different area near by the area to see if they had cars that matched up with vehicles I documented harassing me in the community. The private investigators were just too expensive for long term use.. I tried to get victims compensation from DOJ to relocate but gang stalking victims are denied these funds and investigations.

(7) Before even going to get help from the Fusion Center I noticed some odd stuff from people which drove with Dept. of Public Safety stickers. I had experienced racism along with persistent harassment in the City of Austin by overly zealous and overly funded fusion center stakeholders. Note that I was in Austin to go to CyberTex and left every school afterwards and prior in other states for a decade prior due to encounters with perps and group like the Citizens on Patrol program funded by DOJ I feel as retaliation for taking sheriffs to court in 1997 my case made headlines it was held at the Florida Supreme Court . Also I was accused of a homicide after losing my case . I agreed to take a polygraph test I was informed that if I failed I would be charged with murder I passed it 18 times. They also said the murder weapon was in my house at that time . I allowed an unwarranted search with no court order. I have not fled the country or sought to hide and to this day I am willing to take the polygraph as many times as necessary , truth serum , cat scan free of charge. It appears the Citizens on Patrol is used for cold cases and I have had a few honey pots tell me after some time I was under investigation all of the oddity had cards to sheriffs in their purses .

(8) This was the reason why I sought help from the Fusion Center which they failed to mention in the Fusion Center report. I may unlist the video since it has come with attention in the past and has granted me some media request but I prefer to not be known and just enjoy my life free from public attention. I never went to the Fusion Center and

stated I was there due to non stop government harassment I was there to expose harassment by women and also share a 1 minute video I shared with police concerning Citizens Corps.

I am sharing my side of the story since if this bogus information in this report is shared with every fusion centers it would cause me to be targeted by public and private stakeholders for profit and since the report paints a highly negative image of me in the light of stakeholders and would indeed cause any American to be targeted .

DNI, DIA , National Sheriffs Association, FBI , CIA , DoD , NSA, DHS, DOJ, RISS net, Secret Service , Rotary Club, Lion Club , Eastern Star , Free Masons, FEMA stakeholders or any agency that has me on file as a problem I hope that you will remove any traces of negative statements against me if you have received faulty intelligence about me from a fusion center or command center. I'm just a guy looking to rent , date work live a normal life and to forgot the past. No investigations are needed whats in the past is in the past. I know that since information is shared with stakeholders I need to share my side of the story to clear my name. If any group wishes to deprive me of life, liberty , justice and human rights and surveil and harass me or violate my due process laws understand that I'm not the problem you are. The masonic gang stalking and mobbing that DOJ has been caught lying about years ago in past reports is shameful. Justice cant exist when the justice dept. supports the same activities which it states cause problems. Fortunately Im a good person Ive dealt with this since 1996. Only god knows how many people have been harmed by DOJ and its stakeholders and clandestine groups because of this activity.
