THE UNITED STATES SUPREME COURT IN <u>SIMMONS ET AL. v.</u> <u>UNITED STATES</u>, 390 U.S. 377, 88 S.Ct. 967, 19 L.Ed.2d 1247 (1968), SPECIFICALLY HELD AT PAGE 394 THAT I CANNOT BE COMPELLED TO WAIVE MY SECOND AMENDMENT RIGHTS TO OWN A GUN IN ORDER TO EXERT MY RIGHTS TO LAWFULLY POSSESS MARIJUANA UNDER GOD'S LAW AT GENESIS 1:11; GENESIS 1:12; GENESIS 1:29; GENESIS 1:30 AND EZEKIEL 34:29, WHICH IS PROTECTED BY ARTICLE 1, SECTION 6 OF THE TEXAS STATE CONSTITUTION.

The United States Supreme Court specifically held in Simmons et al. v. United States, 390

U.S. 377, 88 S.Ct. 967, 19 L.Ed.2d 1247 (1968), ... at page 394, that I cannot be compelled to

waive one Constitutional Right in order to exert another and reads:

"In these circumstances, we find it intolerable that one constitutional right should have to be surrendered in order to assert another." <u>Simmons et al. v. United States</u>, 390 U.S. 377, at 394, 88 S.Ct. 967, 19 L.Ed.2d 1247 (1968).

Simmons et al v. United States, supra, holds that I cannot be compelled to waive my 2nd

Amendment Rights to own a gun in order for me to exert my right under Gods laws at Genesis 1:11;

Genesis 1:12; Genesis 1:29; Genesis 1:30 and Ezekiel 34:29, which are protected Constitutional

Rights pursuant to the First Amendment of the United States Constitutin, and Article 1, Section 6

of the Texas State Constitution which reads:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances." **Amendment 1**, **U.S. Constitution**.

"Sec. 6. FREEDOM OF WORSHIP. All men have a natural and indefeasible right to worship Almighty God according to the dictates of their own consciences. No man shall be compelled to attend, erect or support any place of worship, or to maintain any ministry against his consent. No human authority ought, in any case whatever, to control or interfere with the rights of conscience in matters of religion, and no preference shall ever be given by law to any religious society or mode of worship. But it shall be the duty of the Legislature to pass such laws as may be necessary to protect equally every religious denomination in the peaceable enjoyment of its own mode of public worship." Article 1, Section 6 of the Texas State Constitution. And;

"ARTICLE XXVI COMPACT WITH THE UNITED STATES

The following ordinance shall be irrevocable without the consent of the United States and the people of this state: First. That perfect toleration of religious sentiment shall be secured and that

no inhabitant of this state shall ever be molested in person or property on account of his or her mode of religious worship." And;

"And God said, Let the earth bring forth grass, the herb yielding see, and the fruit tree yielding fruit after his kind, whose seed is in itself, upon the earth: and it was so." Genesis 1:11

"And the earth brought forth grass, and herb yielding seed after his kind, and the tree yielding fruit, whose seed was in itself, after his kind: and God saw that it was good." Genesis 1:12

"And God said, Behold, I have given you ever herb bearing seed, which is upon the face of all the earth, and every tree, in the which is the fruit of a tree, in the which is the fruit of a tree yielding seed; to you it shall be for meat." Genesis 1:29

"And to every beast of the earth, and to every fowl of the air, and to every thing that creepeth upon the earth, wherein there is life, I have given every green herb for meat: and it was so." Genesis 1:30

"And I will raise up for them a plant of renown, and they shall be no more consumed with hunger in the land, neither bear the shame of the heathen any more." Ezekiel 34:29

"My people are destroyed for lack of knowledge: because thou hast refused knowledge, I will also refuse thee that thou shall be no Priest to me: and seeing thou hast forgotten the Law of thy God, I will also forget thy children." Hosea 4:6 * * * "And I heard another voice from heaven say: Go out of her, my people, that ye be not partakers of her sins, and that ye receive not of her plagues: . . ." Revelations 18:4 * * * "Then Peter and the Apostles answered, and said, We ought rather to obey God than men." Acts, 5:29 * * * "Draw near to God, and he will draw near to you. Cleanse your hands, ye sinners, and purge your hearts, ye double minded." James 5:8 * * * "And if it seem evil unto vou to serve the Lord, choose you this day whom ye will serve, whether the gods which your fathers served (that were beyond the flood) or the gods of the Amorites, in whose land ye dwell: but I and mine house will serve the Lord." Joshua 24:15 * * * "No servant can serve two masters: for either he shall hate the one, and love the other: or else he shall lean to the one, and despise the other, Ye cannot serve God and riches." Luke 16:13 * * * "Let every soul be subject unto the higher powers: for there is no power but of God: and the powers that be, are ordained of God." Romans 13:1 ** * "Whoever therefore resisteth the power, resisteth the ordinance of God: and they that resist, shall receive to themselves condemnation." Romans 13:2 * * "Wherefore if ye be dead with Christ from the ordinances of the world, why, as though ye lived in the world, are ye burdened with traditions?" Colossians 2:20 * * * "As, Touch not, Taste not, Handle not." Colossians 2:21 * * Which all perish with the using, and are after the commandments and doctrines of men." Colossians 2:22 * * * "And putting out the handwriting of ordinances that was against us, which was contrary to us, he even took it out of the way, and fastened it upon the cross, ... "Colossians 2: 14. * * * "That we henceforth be no more children, wavering and carried about with every wind of doctrine, by the deceit of men, and with craftiness, whereby they lay in wait to deceive." Ephesians, 4:14 * * * "And we know, that the Law is good, if a man use it lawfully." Timothy, 1:8 * * * "Think not that I am come to destroy the Law, or the Prophets. I am not come to destroy them, but to fulfill them." Mathews 5:17. * * "If my people, among whom my Name is called upon, do humble themselves, and pray and seek my presence, and turn from their wicked ways, then will I hear in heaven and be merciful to their sin, and will heal their land: ." 2 Chronicles 7:14.

"Religious beliefs need not be acceptable, logical, consistent, or comprehensible to others in order to merit First Amendment protection. Thomas v. Review Bd., 450 U.S. 707, 714, 67 L. Ed. 2d 624, 101 S. Ct. 1425 (1981). Courts "have nothing to do with determining the reasonableness of the belief." . . . The trial court held that Dr. Backlund's beliefs are sincere. Dr. Backlund's beliefs, being sincere, warrant First Amendment protection." <u>BACKLUND v. BOARD OF</u> COMMISSIONERS, 106 Wn.2d 632, 640, 724 P.2d 981 (Sept. 1986). And;
