

**GOD’S LAW AT 2 CORINTHIANS 3:12 THROUGH 2 CORINTHIANS 3:18 SAYS THAT THE CHILDREN OF ISRAEL MADE IN THE IMAGE OF GOD AS STATED IN GENESIS 1:26 AND GENESIS 1:27 ARE TO HAVE AN OPEN FACE, AND NOT TO COVER YOUR FACE WITH A VEIL OR A MASK, AND GOD’S LAW AT MATTHEW 9:12; MARK 2:7; AND LUKE 5:31 SAYS THAT THE WHOLE OF PEOPLE DO NOT NEED THE DOCTOR OR A MASK, THAT ONLY THE SICK NEED A DOCTOR OR A MASK, AND GOD’S LAW AT NUMBERS 1:49 AND REVELATION 13:6 SAYS THAT THE CHILDREN OF ISRAEL ARE NOT TO BE CHIPPED OR MARKED IN THE RIGHT HAND OR IN OUR FOREHEADS AND WE WILL NOT BE ABLE TO BUY OR SELL SAVE WE THAT HAD THE MARK OR THE NAME OF THE BEAST AT REVELATION 13:17 OR THE NUMBER OF HIS NAME AS CODIFIED AT 42 U.S.C. § 666**

Gods law as codified at 2 Corinthians 3:12 through 2 Corinthians 3:18, clearly provides that Christians are NOT to cover their face, and reads:

**“Seeing then that we have such trust, we use great boldness of speech.” 2 Corinthians 3:12**

**“And we are not as Moses, which put a veil upon his face, that the children of Israel should not look unto the end of that which should be abolished.” 2 Corinthians 3:13**

**“Therefore their minds are hardened: for until this day remaineth the same covering untaken away in the reading of the old Testament, which veil in Christ is put away.” 2 Corinthians 3:14**

**“But even unto this day, when Moses is read, the veil is laid over their hearts.” 2 Corinthians 3:15**

**“Nevertheless, when their heart shall be turned to the Lord, the veil shall be taken away.” 2 Corinthians 3:16**

**“Now the Lord is the Spirit, and where the Spirit of the Lord is, there is liberty.” 2 Corinthians 3:17**

**“But we all behold as in a mirror the glory of the Lord with open face, and are changed into the same image, from glory to glory, as by the Spirit of the Lord.” 2 Corinthians 3:18**

Gods law at Matthew 9:12; Mark 2:7, and Luke 5:31, says that the whole of the people don’t need the doctor or a mask, and that only the sick need the doctor or a mask, and clearly reads:

**“Now when Jesus heard it, he said unto them, The whole need not the Physician, but they that are sick.” Matthew 9:12**

**“Now when Jesus heard it, he said unto them, The whole have no need of the Physician, but the sick. I came not to call the righteous, but the sinners to repentance.” Mark 2:7**

“Then Jesus answered, and said unto them, They that are whole, need not the Physician, but they that are sick.” **Luke 5:31**

### **THE BIBLE SAYS THAT THE CHILDREN OF ISRAEL ARE NOT TO BE NUMBERED, MARKED OR CHIPPED!**

“Only thou shalt not number the tribe of Levi, neither take the sum of them among the children of Israel.” **Numbers 1:49**

“And he made all, both small and great, rich and poor, free and bond, to receive a mark in their right hand or in their foreheads.” **Revelation 13:16**

“And that no man might buy or sell, save he that had the mark or the name of the beast or the number of his name.” **Revelation 13:17**

“And the third Angel followed them, saying with a loud voice, If any man worship the beast and his image, and receive his mark in his forehead, or on his hand.” **Revelation 14:9**

“The same shall drink of the wine of wrath of God, yea, of the pure wine, which is poured into the cup of his wrath, and he shall be tormented in fire and brimstone before holy Angels, and before the Lamb.” **Revelation 14:10**

“And the smoke of their torment shall ascend evermore: and they shall have no rest day nor night, which worship the beast and his name.” **Revelations 14:11**

“And I heard another voice from heaven say: Go out of her, my people, that ye be not partakers of her sins, and that ye receive not of her plagues: . . .” **Revelation 18:4**

### **I HAVE A FIRST AMENDMENT RELIGIOUS RIGHT NOT TO WEAR A MASK!**

“Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances.” **Amendment 1, U.S. Constitution.**

“Religious beliefs need not be acceptable, logical, consistent, or comprehensible to others in order to merit First Amendment protection. *Thomas v. Review Bd.*, 450 U.S. 707, 714, 67 L. Ed. 2d 624, 101 S. Ct. 1425 (1981). Courts “have nothing to do with determining the reasonableness of the belief.” *State ex rel. Bolling v. Superior Court*, 16 Wn.2d 373, 384, 133 P.2d 803 (1943) (quoting *Barnette v. West Va. Bd. Of Educ.*, 47 F. Supp. 251, 253 (S.D. W. Va. 1942), *aff’d*, 319 U.S. 624, 147 A.L.R. 674 (1943)). The trial court held that Dr. Backlund’s beliefs are sincere. Dr. Backlund’s beliefs, being sincere, warrant First Amendment protection.” *Backlund v. Board of Commissioners*, 106 Wn.2d 632, at 640, 724 P.2d 981 (Sept. 1986); *Malyon v. Pierce County*, 131 Wn.2d 779, at 784-785, 935 P.2d 1272 (April 1997); *Perry v. School Dist. No. 81*, 54 Wn. (2d) 886, at 897-898 (October 8, 1959); *Southcenter Joint Venture v. NDPC*, 113 Wn.2d 413, at 438-439, 780 P.2d 1282 (Oct. 1989). Free exercise clause forbids government from adopting laws designed to suppress religious belief or practice. *American Life League, Inc. v. Reno*, 47 F3d 642 (4th Cir. 1995); Protection of free exercise clause extends to all sincere religious beliefs; courts may not evaluate religious truth. *Ferguson v. C.I.R.*, 921 F2d 588 (5th Cir. 1991). See also **42 U.S.C. § 1396f**
