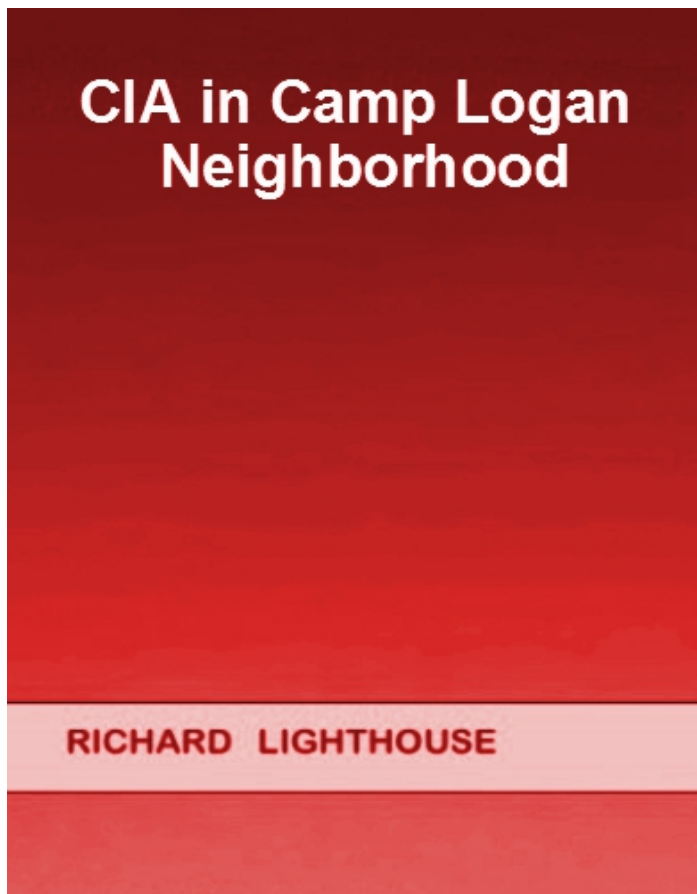

Abstract

Revision 2A: CIA agents are residing in an expensive neighborhood, called Camp Logan, in Houston, Texas at taxpayer expense. These homes cost up to \$1MM. These agents are being pampered, not just in Houston, but probably in every major U.S. city, to “purchase” their loyalty. It is fraudulent, period. Government employees are not entitled to free, luxury housing in the United States. This is waste and abuse of public funds – a Felony.
