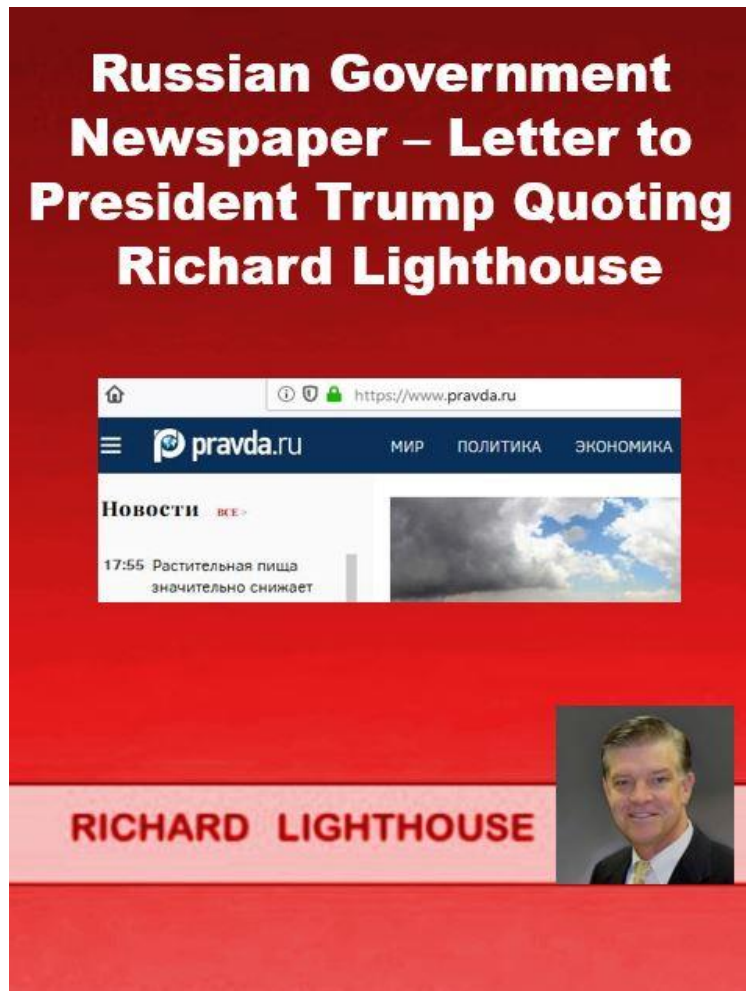

Pravda is the official government newspaper in Russia. Intelligence agencies around the world read it, to learn of the government's opinions on world matters. The Newspaper is funded and reviewed by Russian Government officials on many matters. There is no equivalent newspaper in the United States.

This short ebook documents criminal activity of the Clowns, Idiots, and Assholes (CIA) which has been classified to hide its discovery. This constitutes a violation of Presidential Executive Order 13526, which prohibits the classification of material to hide criminal activity. On 18 January 2017, Richard Lighthouse was quoted in the newspaper, Pravda, which is the official government newspaper in Russia. This is significant because the entire contents of Pravda are considered foreign intelligence gathering for the CIA. A few days earlier, my Internet Protocol addresses for my iphone, home computer, and work computer were all routed to a company, Incapsula, to use their technology to hide my IP location by automatically changing it many times each day. There are three companies that were ordered to do this simultaneously – MetroPCS (a subsidiary of TMobile), Comcast (work computer), and AT&T (home computer). When three large companies do something at the same time – you can be certain they were ordered to do it. So how do we know the CIA ordered this? Because under Presidential Executive Order 12333, only the CIA has the authority to act on foreign intelligence, and the reason they ordered this before publication, is because they knew it would be published. This proves the obvious – that the CIA hacked the emails servers of Pravda, a long time ago.

Pravda is not operated like a commercial newspaper in the United States. It is a government bureaucracy, that must get approvals and edits on anything important that is published. The article that I am referring to – took weeks to draft and circulate for approvals and changes. This is what gave the CIA plenty of time to know that it would be published soon, and gave them plenty of time to hack my phone and computers. I have filed complaints with the Federal Communications Commission (FCC), and they have failed to investigate or directly respond to my complaints as yet. MetroPCS has responded twice, but failed to answer any of my questions. This suggests MetroPCS has been served a National Security Letter (NSL), in violation of Executive Order 13526. More than 300,000 National Security Letters have been issued in the United States.

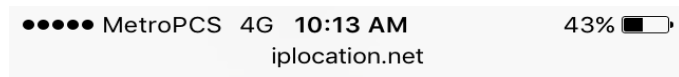

Incapsula is a subsidiary of Imperva, located in California. This re-routing was done to my iphone (MetroPCS), my home computer (AT&T), and my work computer (Comcast-Logix).

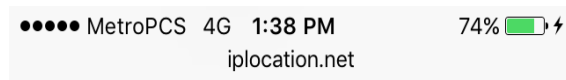

According to geolocation statistics for IP addresses – the IP address should correctly identify your city location more than 80% of the time, particularly if you live in the United States. However, for my iphone, the IP location is almost always wrong. Note the 5-bar

signal strength in the upper left corner.

The CIA knew that Pravda would soon publish this article. Pravda is not operated like a commercial newspaper in the United States. It is a government bureaucracy, that must get approvals and edits on anything important, especially political, that is published. The article that I am referring to – took weeks to draft and circulate for approvals and changes. This is what gave the CIA plenty of time to know that it would be published soon.

How can I be certain that the CIA was behind this? Because, according to Presidential Executive Order 12333, only the CIA may act or authorize action on foreign intelligence. (They probably told the FBI to send National Security Letters to these 3 companies.) What

makes this unusual, it occurred a few days before the article was published – proving the obvious, that the CIA had already hacked the email server for Pravda.

The information leaked by Ed Snowden and the recent Vault 7 files of the CIA make it clear, the CIA will hack anything domestic or foreign, and consider themselves above the law. The criminal activities of these Clowns, Idiots, and Assholes (CIA) are a threat to all Americans and the U.S. Constitution. These criminals must be stopped. One of the problems with this agency is – how they train their personnel. The US Military is prohibited by law from targeting US citizens with PSYOPS within US borders under Executive Order S-1233, DOD Directive S-3321.1 and National Security Directive 130. Again, this further implicates the CIA for these criminal acts.
