My name is Tiffany Fontenot. This email concerns Christopher Wray, the Targeted Justice Lawsuit, and the TSDB (Terror Screening Database.)

I submitted an email to the Weaponization Committee to one address, but it said for interns or whistleblowers, so I'm making sure you all get this by sending it to your individual email addresses.

I'm attaching the document I submitted to this email. Please be sure you read it thoroughly. It has a few changes compared to what I submitted originally.

Also, here are some questions for the Weaponization Committee:

Will the Weaponization Committee pledge to make sure Amy Holem's path (and anyone else bringing these apps to the public) is clear to getting her app out to people being tortured by the global Stasi Public Private Partnership for profit and enslavement?

Will the Weaponization Committee create a proper system for victims to be tested for the nonconsensual studies we've been enrolled in and get legislation together that includes the death penalty for nonconsensual experimentation including formally abolishing and making torture lists and Mk Ultra death penalty crimes?

Will the Weaponization Committee send each victim all data, what was done to us, and provide for nonweaponized testing that can be done that will be accepted by the courts for what's been done to us?

Nonconsensual testing is a form of trafficking. Trafficking and aiding and abetting traffickers needs to be illegal with a mandatory death penalty consequence to include for putting anyone in a nonconsensual study.

This has gone too far and now the reigns must be pulled in to safeguard not just Humanity but literally all biology on the planet from the disgusting transhuman onslaught that looks to me to have been brought forward in a literal quest to overthrow God. It is enough.

On a personal level, my family and I need to know what studies we've been placed in and what these criminals have done to our bodies with proper restitution and recompense provided. No hiding of cures they found either because that may be part of being made whole from what's been done to all of us.

"But when a long train of abuses and usurpations, pursuing invariably the same object, evinces a design to reduce them under absolute despotism, it is their right, it is their duty, to throw off such government, and to provide new guards for their future security."
